## **Personal Injury**

Angela is able to advise in cases involving all forms of catastrophic injury but her areas of expertise are principally:



- Chronic Pain including issues of CRPS and fibromyalgia
- Cases involving psychiatrically driven chronic pain conditions, including somatoform or conversion disorders
- Functional Neurological Disorder
- Fraud cases involving malingering/exaggeration as well as fraud rings, ghost passengers and low velocity impacts
- Brain Injury including subtle brain injury
- Amputation
- Cases involving injury to teachers, carers, and nurses caused by pupils and patients
- Fatal Accidents

Angela is adept at identifying when issues of chronic pain might arise and is able to offer strategic advice, test medical evidence and utilise her forensic skills to ensure the best outcome for clients. Very often in these types of claim, causation is hotly disputed and issues of malingering, fraud and exaggeration arise. Angela has built up a deep understanding of these chronic pain cases working with medical experts in many different specialisms over the years. In particular, she has considerable experience of effectively adopting a multidisciplinary approach both to establishing and challenging chronic pain claims.

She is known for her ability to effectively marshal evidence in cases involving complex causation issues.

In significant brain injury cases Angela is often involved at an early stage in collaboration with the other side to provide rehabilitation and educational provision and ensure the right expert evidence is obtained.

Angela is alert to capacity issues and is able to advise appropriately at all stages.

She is able to advise on liability issues across the spectrum of road traffic, public liability and employers' liability claims and regularly deals with cases involving multiple defendants.

Angela is instructed in a number of cases with multiple accident reconstruction experts.

Angela has a wealth of experience in cases involving the MIB and in cases where insurance issues under the Road Traffic Act 1988 arise.

Examples of recent cases:

Obtained settlement for D at mediation of a complex case involving two accidents, a disputed brain injury and complex pre and post accident psychiatric issues. Claim pleaded at over £4million, settled for less than 20% of that value.

Obtained settlement for D at JSM in a spinal cord injury case with extensive urological issues and accommodation needs.

Secured dismissal of a potentially high value bus v pedestrian claim at trial on liability.

Secured settlement at mediation for one of 6 D's in a high value Fatal Accident claim arising out of a multi-vehicle collision involving a pedestrian. Multiple accident reconstruction experts instructed.

Advising one of 6 D's in a high value Fatal Accident claim arising out of a multi-vehicle collision involving a pedestrian. Multiple accident reconstruction experts instructed.

Advising D in a claim valued at in excess of £1 million with complex causation issues and alleged subtle brain injury. Advising C in a claim valued at £2.5million for life changing lower limb injuries and complex psychiatric diagnoses.

Advised D in a claim valued at over £4million, involving a significant leg injury but issues of disproportionate ongoing



pain impacting on ability to work. Settled at JSM for a ¼ of that sum.

Acting for a brain injured child over a number of years where a collaborative approach with the insurer has resulted in ongoing rehabilitation and education packages eventually resulting in a £multi-million settlement.

Successful High Court claim involving injury to a nurse in a care home resulting from negligent systems of work. Acted for D in a case involving extensive burns to a resident in a care home for adults with learning disabilities. Value £1.4 million.

## **Fraud**

Angela has extensive experience of cases involving:

- Exaggeration/Malingering in particular those cases involving alleged chronic pain syndromes and psychologically driven pain.
- · Ghost passengers
- Fraud Rings
- · Low velocity
- Staged accidents
- · Findings of fundamental dishonesty

She is regularly instructed by leading insurers to draft Defences and advise in cases where fraud is suspected. Angela frequently confers with medical experts in fraud cases and is happy to advise at an early stage on evidence and tactics.

Angela has had considerable success in persuading Courts to make findings of fundamental dishonesty in QUOCS cases.

Angela is adept at scrutinising, assessing and deploying surveillance evidence, social media evidence and insurance database material.

Examples of recent cases:

Settled a claim pleaded at in excess of £1.2 million for a figure less than 20% of that sum as a result of detailed investigations into the Claimant's employment history and targeted questions to experts.

Successfully defended a claim where low velocity arguments were deployed and feigned injury was alleged. Angela utilised social media evidence in cross examination. Resulted in a finding of fundamental dishonesty.

# **Clinical Negligence**

Angela has a range of experience across the breath of clinical negligence cases. She is particularly interested in cases with tricky causation issues such as those where there is interplay between personal injury claims and subsequent clinical negligence allegations.

Angela acts for both Claimants and Defendants.

Recent cases include:

- Failure to diagnoses ischemia resulting in amputation
- Negligent hip surgery arising out of an accident at work for which there was an ongoing personal injury claim for which liability was in dispute.

- Alleged negligently performed gynaecological surgery resulting in urinary incontinence and prolapse.
- Case involving the death of a patient arising from admitted negligence where the issue was the length and



quality of life the deceased would have enjoyed had she lived for the purposes of a dependency claim.

- Case arising from a failure to diagnose diabetes with significant causation issues.
- Bowel injury arising out of alleged negligent insertion of a suprapubic catheter where significant changes to quality of life were alleged against a background of significant pre-morbid history.

## **Industrial Disease**

Angela is regularly instructed in cases involving:

- · Occupational asthma
- Dermatological conditions
- Vibration White Finger
- · Industrial deafness
- NFCI

She is able to advise in complex and historical cases involving multiple defendants.

#### Insurance

With experience of policy issues in both road traffic and property insurance, Angela is able to advise on a wide range of issues including coverage, avoidance, indemnity and fraud.

# **Costs & Litigation Funding**
