She frequently represents parties in trials, CCMCs, application hearings and inquests. Elizabeth is often instructed on paperwork matters advising and drafting pleadings. She is comfortable acting in multi-track and high value cases.

Elizabeth is experienced in clinical negligence cases, and she edits 12KBW's clinical negligence blog.

Elizabeth regularly represents interested persons in inquest hearings, in particular those relating to circumstances of alleged clinical negligence in hospitals.

With her background of 2 science Masters degrees, Elizabeth is well-placed to understand the complex biological issues which can arise in expert evidence.

Elizabeth has dealt with cases involving:

- · Alleged negligence in surgical procedures, in particular orthopaedic surgery and general surgery
- Alleged negligence in diagnostic procedures e.g. colonoscopy
- Delays in diagnosis/treatment, including various types of cancer, stroke, orthopaedic injuries, compartment syndrome, endocrine condition, kidney injury and appendicitis
- · Alleged deficiencies in nursing care and care of the elderly, e.g. pressure sores and falls risk
- Obstetrics/gynaecology, including those involving uterine injury, ectopic pregnancy
- Neonatal death
- Administration of incorrect medication doses
- · Alleged negligence in cannulation, injection, tubing and aspiration
- Urological injuries
- · Optometry and ophthalmology

International & Travel

Elizabeth is experienced in cases relating to injury and illness abroad.

She is very familiar with claims under the Package Travel Regulations relating to accidents and illness abroad and advising on matters relating to local standards evidence.

Elizabeth is also happy to advise on points relating to applicable law and jurisdiction under the Brussels Recast and Rome II Regulations, as well as dealing with cases under the Athens Convention and Montreal Convention.

Inquests

Elizabeth represents families and other interested persons at inquests, helping them navigate this challenging and emotional process.

She regularly acts in complex, multi-day inquests, which often involve submissions on the engagement of Article 2 of the European Convention of Human Rights.

The main area of focus for these inquests is clinical negligence, where there can be difficult issues of medical causation.

Elizabeth understands the need for sensitivity in inquests, as well as for a full and fair exploration of the circumstances of each case.

She is happy to act on a CFA basis.

Elizabeth's recent inquests include:

- Acting for the family in a 5-day Article 2 inquest into the death of their 1 day old baby at a hospital. The coroner identified multiple failings in the neonatal care and found that the baby would have likely survived had they been transferred in utero to a Neonatal Intensive Care Unit.
- Acting for the family in a 3-day inquest into the death of their 1 day old baby at a hospital, who passed away as a result of infection contracted in utero following prolonged rupture of membranes. The coroner found a number of

failings in the obstetric care provided to the mother, and that there was a delay in delivery.

- Representing the family in a 3-day inquest into the death of a nursing home resident, who had a complex
 medical history including being bedbound with a degenerative condition and pressure sores. The family were
 concerned about the care that their loved one had received in the nursing home.
- Acting for the family in a multi-day inquest into the death of a young adult who suffered a significant asthma attack but left the medical facility due to the lengthy waiting time.
- Acting for the family in a case where the delay in clinicians investigating, diagnosing and treating sepsis contributed to the death.
- Representing the family in an inquest where the deceased died during a routine medical procedure.
- Acting for an interested person in an Article 2 jury inquest, where there was a verdict of unlawful killing.
- Representing an interested person in a jury inquest about the death of a tradesman who died on-site from electrocution.
- Acting for the families in inquests involving allegations regarding the administration of medication.

Abuse

Elizabeth accepts instructions in cases involving mistreatment, abuse and sexual abuse. She understands the involvement of issues of both human rights and tort, as well as limitation.

Industrial Disease

Elizabeth acts in NIHL and HAVS/VWF cases and is happy to deal with both fast-track and high value cases.

Elizabeth has experience of drafting pleadings and advising for Claimants in NIHL cases. She is familiar with the issues of causation and limitation that arise in such cases. She has more recently been instructed in several military NIHL cases.

Credit Hire

Elizabeth frequently acts for Defendants in credit hire claims. She has a good knowledge of the case law and takes a forensic approach to quantum.

She is adept at dealing with issues of need, period, intervention and impecuniosity, as well as at analysing basic hire rates evidence.

Insurance

Elizabeth's experience of RTA and credit hire claims has often involved issues of insurance law, and she has a good understanding of policy disputes.
