### **Fraud**

Helen is frequently instructed in fraud cases, both as sole and junior counsel and welcomes instructions in this field.

She was long-standing junior to a silk for the defendant in an 8-figure TBI claim in which fundamental dishonesty was alleged. Her forensic analysis of the huge quantities of evidence in that case contributed to the case settling for a small fraction of the pleaded claim, weeks before trial.

Her current portfolio of fraud cases includes a case in which she was instructed as junior to a silk in the original action which was compromised and approved, but in which she is now part of the team bringing a new action to have that approved compromise set aside for a fraud that only came to light post-approval. The case involves extremely complex expert and factual evidence, as well as niche procedural issues and a domestic freezing order. Helen has been involved at all stages and enjoyed working collaboratively in a team.
