Teenager killed by a car when the brakes on his bike failed - cycle shop sued – liability in issue – both parents claim as secondary victims	not settled
Quantum – non-organic problems - chronic fatigue syndrome? Exaggeration?	settled
Stress at work - teacher	settled
Man kicked by horse -Animals Act - liability and quantum — extent of pre- traumatic amnesia how reliable was the Claimant's pre-accident memory	settled
Stress at work – hospital administrator	settled
Man on ladder trying to get access to a ceiling void in an office building. Sues employer and occupier, who brings in three parties involved in the maintenance of the building	settled
Car overturns and passenger paraplegic – sues driver and highway authority – the latter brings in two contractors responsible for the state of the road	settled
Fatal – RTA – crossroads – motorbike travelling too fast – car turning across its path	not settled but did shortly afterwards
Courier cyclist collides with pedestrian — issue as to whether he was selfemployed, vicarious liability	settled
Appropriate seat belt reduction – what injuries would have been suffered if worn – Quantum subtle brain injury	settled
Aircraft crash – chronic pain and psychiatric issues – meaning of disability in, and application of, the Ogden Tables	settled

Tiger Moth crash – passenger died but pilot survived – liability in issue – criminal trial pending – mother of passenger pleaded a secondary victim claim	not settled on the day but did shortly afterwards
Motorway pile-ups – cars blaming each other and the icy road surface – contrib, should injured claimants have stayed in their cars – argument between D of T and contractors as to whether the protocols were clear or had not been followed	settled
Causation – quantum – link between lifting accident and development of various syndromes including PoTs	not settled. defendant without relevant instructions
Causation – quantum – chronic pain syndrome - PTSD	settled
Stress at work – journalist – personal injury and employment claims	settled
Stress at work – university lecturer – personal injury and employment claims	not settled on the day but did shortly afterwards
Fatal accident act claim — did the Claimant have to give credit for shares inherited	settled
Carpenter blinded in one eye on a building site – future earnings – residual earning capacity	settled
Child suffered brain damage inhaling smoke from fire at domestic premises - liability in issue - fire and metallurgical experts	not settled
Claimant falls from height on a construction site – arguments as to contrib and apportionment between the employer and other contractors	not settled

Elderly pedestrian struck by bus – amputation – what would have happened in any event	not settled
Loss of earning capacity – young man injured back – investigations revealed pre- existing abnormalities that would probably not otherwise have been detected for some years	settled
Car hits tree — no other vehicle involved — issues of ex turpi, drink, drugs, and knowing no insurance etc	settled
Head injury on construction site – borderline capacity – life expectancy	not settled on the day but did shortly afterwards
Visitor to a block of flats fell over a low wall – arguments between occupier and managing agent	not settled
