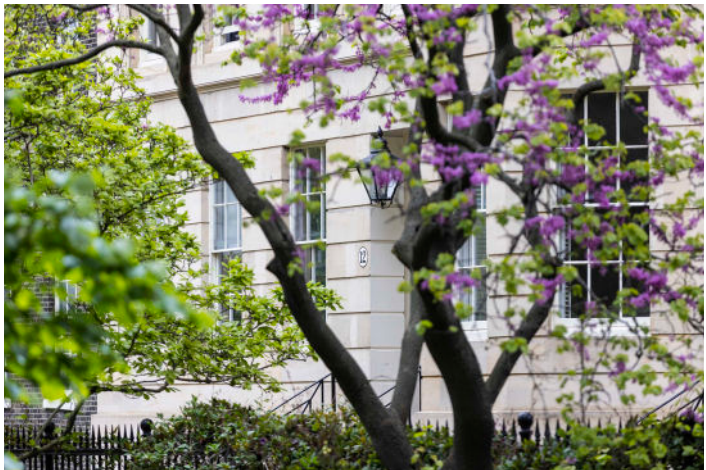

Personal Injury

Our Personal Injury Team enjoyed a hugely successful 2025.

Reaffirming our leading position at the Bar in personal injury law, we retained Band 1/Tier 1 rankings across both major legal directories. We secured seven barrister promotions in the rankings this year for PI including Steven Snowden KC, Head of Chambers, moving up to Star Individual. We have the highest number of ranked barristers for personal injury at the Bar (51).

We were delighted to be awarded a new set ranking for Motor Insurance Fraud by Chambers & Partners in recognition of our expertise in motor indemnity issues and personal injury claims involving elements of dishonesty.

12KBW was shortlisted for Personal Injury Set of the Year at both the Chambers UK Bar Awards and the Legal 500 Bar Awards. 12KBW has won Personal Injury Set of the Year six times in recent years at the Chambers Bar Awards.

[Pankaj Madan](#), a member of both 12KBW and Exchange Chambers, won Personal Injury Junior of the Year at the Legal 500 Awards. William Audland KC was shortlisted for Personal Injury Silk of the Year and Gemma Scott was shortlisted for Personal Injury Junior of the Year. All of us at 12KBW warmly congratulate Pankaj, William and Gemma for their recognition at the Legal 500 Bar Awards.

In-person knowledge sharing remains at the heart of what we do, through our CPD accredited training events. In July, our fully booked [12KBW Annual Conference](#) featured a wide choice of talks including motor indemnity arguments to run post-Brexit, deploying and negating adverse inferences, calculating loss of earnings, and negotiating tactics for settling claims.

Our cases span the full spectrum of personal injury law.

Steven Snowden KC and Charley Turton acted for one of the defendants in *Verdin v Hunter*, where a mountain biking accident had left the claimant paraplegic. The case was successfully settled on liability and quantum at mediation.

Long-running, maximum-severity brain injury claim [Clarke v Poole](#) was successfully settled. Steven Snowden KC represented the defendant in a JSM, which resulted in the claimant abandoning an appeal of a High Court judgment in favour of the defendant.

William Audland KC continues to lead Niall Maclean, Gemma Scott, Charley Turton, Spencer Turner and Jessica Muurman in defence of the Rugby Football League on over

100 claims brought by former professional players who allege they suffered various neurological conditions from repeated concussions during their careers.

Representing the Football Association of Wales, Steven Snowden KC leads Vanessa Cashman in respect of footballers and former footballers claiming damages for alleged neurological injury resulting from concussions. 80+ claimants are seeking damages against the FA, the English Football League and the Football Association of Wales.

In a complex brain injury case [Hemingway v Robena Contract Furnishings Ltd.](#), the claimant sought over £2.4m, but the judge awarded £723,916 following representations from Nigel Lewers for the defendant. This case demonstrated the importance of using specialists aligned with the core issues and the Court's preference for reasonable opinion from experts over speculative theories which undermine a claim.

James Candlin co-represented the former CEO of the Channel Islands Co-operative Society. Following a 17 day trial, the Jersey Royal Court found the Society breached its duty of care to its former Chief Executive, causing him a psychiatric injury through a sustained campaign to remove him from office. He was awarded £3.5m in damages.

Arun Katyar represented the Defendant in [Mrs Zakia Din v Aviva Insurance Ltd.](#), securing both dismissal of the claimant's personal injury claim and a finding of fundamental dishonesty.

Andrew McLaughlin appeared for the Lord Byron Hotel in [Danny Malone v Eastern Counties Linen and the Lord Byron Hotel](#), which saw the court reject a claim in its entirety by a delivery driver who fell on the hotel stairs. After a 3-day trial, the judge held the Claimant had failed to prove that the staircase was dangerous and ruled the hotel was not negligent.

Daniel Tobin successfully represented the defendants in *Bali v I-I Couriers & Walsingham Insurance*. The Court of Appeal confirmed that the date for service of proceedings runs from the date of issue stamped on the claim form and declined to exercise its discretion by extending the time for service in the claimant's favour.

Catherine Peck successfully represented defendants at three separate high-value liability trials involving pedestrians and arguments relating to 'lines of sight'. *Pashamov v Taylor and Edward Vinson* is thought to be the first case in which a claimant's qualified one-way costs shifting protection

was taken into consideration by the court when making a Sanderson costs order against an unsuccessful co-defendant.

She also appeared on behalf of third party AR Richards Ltd in a [three-day liability trial](#), where the claim against the company arising out of a fatal accident at a racetrack was dismissed.

William Audland KC and David White secured a substantial seven-figure settlement for a police officer who suffered a life-changing brain injury following a collision with an HGV.

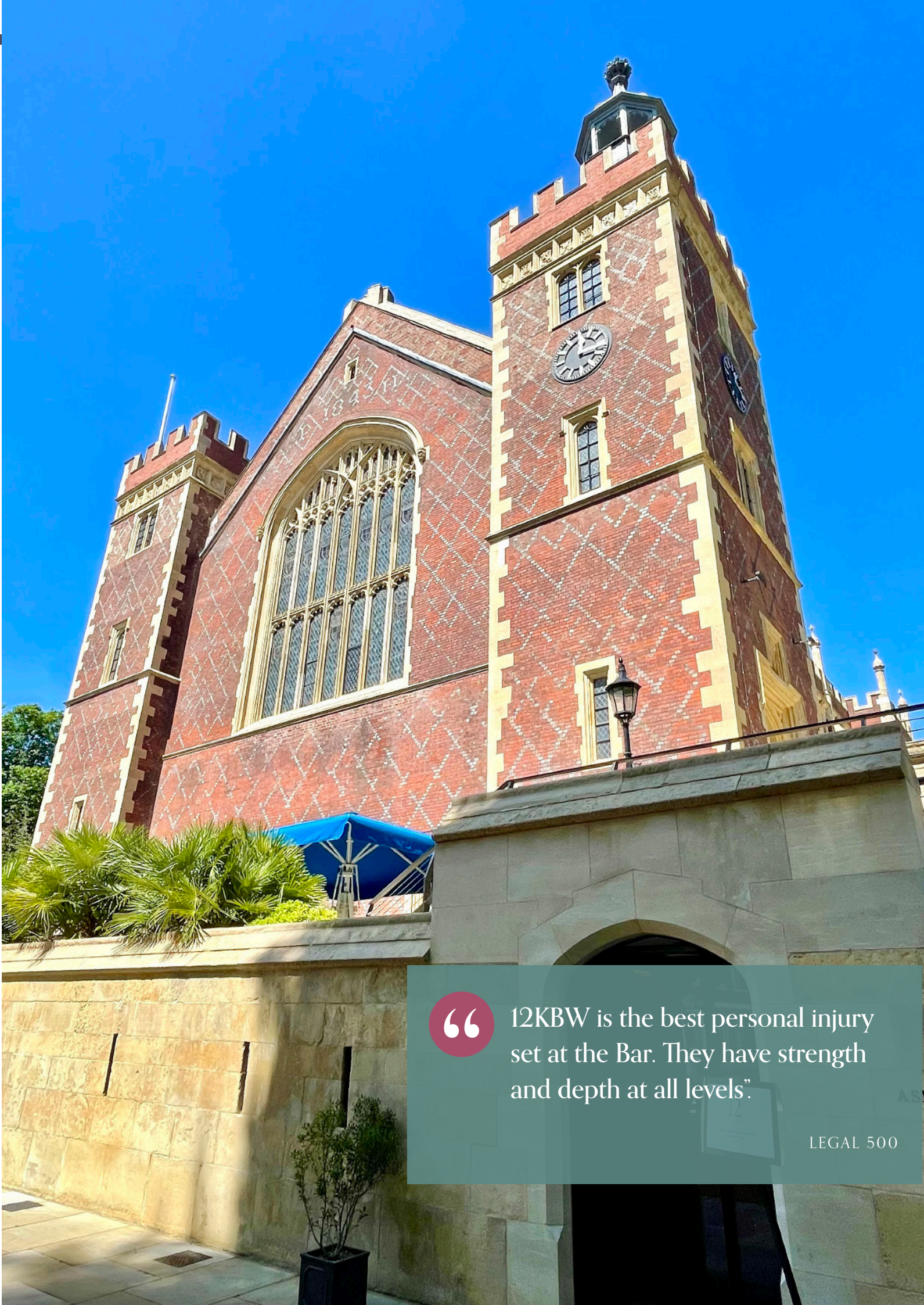
Isaac Hogarth appeared for insurer Aviva in a successful strike-out application in the High Court - [Keating v Abdisalan and Aviva Insurance Ltd](#) - involving a fatal RTA and the question of whether an Estate inherits a claim for diminution in value of lost services.

James Pickering secured a £900,000 [settlement for a former Royal Navy chef](#) who suffered a non-freezing cold injury while on an exercise in Norway.

Robert Oldham acted as junior counsel for the appellant in [PMC v A Local Health Board](#). The Court of Appeal clarified the High Court's inherent jurisdiction to make anonymity orders to give protection to vulnerable claimants. The judgment has far-reaching consequences for personal injury litigation and it affirms the importance of the proper administration of justice in cases involving vulnerable individuals, balancing this with the open justice principle.

12KBW's PI Blog continues to thrive under our Editor, Dr Achas Burin. Blog posts have covered a wide range of issues of interest to practitioners including the Assisted Dying Bill, civil claims for abuse, thresholds of recklessness and negligence in competitive sport, and e-scooter claims. LEGAL 500

Industrial Disease

The [Court of Appeal judgment in *Johnstone v Fawcett's Garage*](#) loomed large for asbestos lawyers in 2025 with far-reaching consequences for mesothelioma claims. Steven Snowden KC, John-Paul Swoboda KC and Helen Waller of our Industrial Disease Team, acted for the appellants.

At the heart of the appeal was the judge's assessment of the increase in risk of mesothelioma caused by the low dose of exposure.

Judges ruled that direct risk assessment, and reliance on Hodgson & Darnton, is a permissible method of evaluating material increase in risk of mesothelioma in low exposure cases. Nevertheless, the judgment allows for claimants to challenge the use of Hodgson & Darnton. The Court of Appeal did, however, rule out use of the absolute risk approach.

Michael Rawlinson KC leads the group claim for c.4,000 cancer victims against Johnson and Johnson alleging their condition was caused in law by using cosmetic talcum powder. Rebecca Henshaw-Keene and Corinne Novell are also instructed for the claimants.

Patrick Kerr, Head of 12KBW's Industrial Disease Team, settled a secondary exposure, product liability case against Cape Building Products Ltd and Cape Intermediate Holdings Ltd, following a disclosure application.

Rachit Buch secured judgment on liability in *Harris v Cwm Taf Health Board*; a secondary exposure claim arising from Mrs Harris's washing of her then boyfriend's overalls. The parties agreed to adjourn services in the last years.

John-Paul Swoboda KC - a preeminent specialist in asbestos litigation - joined the ranks of our expert silks in this area, following his appointment as King's Counsel in March.

Our Industrial Disease Team hosted three major events for our clients and partners over the course of the year.

In February, we hosted a packed social event in London for our friends at Mesothelioma UK. We were joined by solicitors from London and many other regions. All funds raised on the night went to Meso UK, together with further match funding from our team.

In May and September we hosted our Asbestos Seminars in London and Manchester respectively, with speakers from across the team. We delved into the latest updates and strategic considerations across a range of asbestos-related issues from employment status and the implications of Johnstone to product liability insights and the Assisted Dying Bill.

In June, we sponsored the Asbestos & the Law Conference hosted by the Merseyside Asbestos Victims Support Group. Patrick Kerr chaired the conference. Michael Rawlinson KC spoke on 'Cuthbert & White related issues'. Michael Brace addressed what the Johnstone case will mean for future cases.

In October, we returned to Manchester as the headline sponsor at APIL's Asbestos Conference. John-Paul Swoboda KC spoke on the use of epidemiology. Gemma Scott, chaired the afternoon sessions on low exposure issues, product liability and American claims.

James Pickering continues to head our International & Travel Team in a year marked by improved rankings, high profile cases and training for our clients, both here and abroad.

We maintained our Band 1 Chambers & Partners ranking and further increased the number of ranked barristers. 10 members of the team are now ranked as leading practitioners for International Personal Injury in the Chambers UK Bar Guide. John-Paul Swoboda KC, a specialist in private international law, joined the ranks of our silks specialising in this area following his appointment as King's Counsel in March.

12KBW's International & Travel Team held its annual seminar in October. Speakers from our team covered the latest updates on Recital 33 of Rome II (John-Paul Swoboda KC), package travel (James Candlin, Alex Carington), jurisdiction (Peter Hale), expert evidence in cross-border cases (David White, Cressida Mawdesley-Thomas) and aviation (Charley Turton, Peter Hale).

We continue to be well represented at key cross-border events in the UK and overseas. We co-sponsored a number of PEOPIL Conferences this year including their Annual Conference (Brussels), New Lawyers Group Conference and RTA Conference (Kraków).

[12KBW's International & Travel Law Blog](#) continues to be the first port of call for updates on key developments in English private international law and the law of international travel. Topics this year have included FNC challenges,

Package Travel Regulations reform and recognition and enforcement of foreign judgments.

Our barristers continue to be instructed in many of the most important cross-border and travel cases. [Patrick Vincent KC and James Pickering secured damages for a brain injured client following a 14-day High Court cross-border personal injury claim.](#) Spanish penalty interest was also awarded. The 103-page judgment deals with many issues which are essential reading for cross-border personal injury lawyers, such as apportionment of liability under Spanish law and application of the Baremo.

Nina Ross was instructed in claims brought by Sri Lankan children and adults who allege that they were detained in prison-like conditions in Diego Garcia between 2021 and 2024. Their claims for false imprisonment and in negligence have been brought in the Supreme Court of the British Indian Ocean Territory against the General Counsel for the British Indian Ocean Territory and G4S Risk Consulting Limited.

[William Audland KC and David White were instructed in a catastrophic injury case where the client suffered an above knee amputation and brain injury following a construction site accident in Jersey.](#) The case proceeded to a five day contested liability trial in Jersey. The Court granted judgment against both defendants, held that they were jointly and severally liable, and apportioned liability between both defendants.

Charley Turton is instructed in a high-value claim arising from an aviation disaster which claimed 71 lives. She co-represents survivors of the accident, and family members of persons killed, when LaMia Flight 2933 crashed near Medellín in Colombia. Jessica Muurman is a member of the counsel team to plead losses arising under Colombian, Brazilian and English law.

Clinical Negligence

After fifteen years of distinguished leadership, Henry Charles stepped down as Head of 12KBW's Clinical Negligence Team in July. We pay tribute to Henry's impressive legacy. He remains an integral member of the team.

Vanessa Cashman and Isaac Hogarth were appointed as Joint Heads in his place. Vanessa is described as "a superstar in the field of clinical negligence" by the Chambers Bar Guide. Isaac, likewise ranked as a leading junior in Chambers & Partners, is praised as "an excellent barrister and a calm presence on the most testing of medical negligence cases". We are in safe hands as they lead the team onwards and upwards.

In another significant landmark for the team, John-Paul Swoboda was appointed King's Counsel. He specialises in high value clinical negligence work. We warmly congratulate John-Paul on this well-deserved appointment.

We were recognised once again by Chambers & Partners and the Legal 500 as one of the leading chambers in the UK for clinical negligence law. 14 members of the team are now ranked across the legal directories.

We hosted a packed house at Inner Temple, London for our [Clinical Negligence Seminar](#) in October. Talks focused on two critical areas. John-Paul Swoboda KC and Vanessa Cashman of 12KBW tackled cerebral palsy (addressing breach of duty). They were joined by guest speaker Roobin Jokhi, Consultant in Obstetrics, Maternal & Fetal Medicine.

Dr David Sharpe KC and Isaac Hogarth of 12KBW covered sepsis (focusing on causation) alongside Dr Chris Danbury, Consultant in Intensive Care Medicine. Our seminar concluded with a panel discussion on legal and procedural issues including anonymity orders post PMC. Andrew Roy KC chaired the discussion with our 12KBW panellists, Thea Wilson, Elizabeth Boulden, Charley Turton and Robert Oldham.

We were strongly represented at industry events, in particular the AvMA Clinical Negligence Conference in March attended by John-Paul Swoboda KC, Henry Charles, Vanessa Cashman, Gareth McAloon, Isaac Hogarth, Cressida Mawdesley-Thomas, Elizabeth Boulden and Charley Turton.

Steven Snowden KC chaired the AvMA Cerebral Palsy and Brain Injury Cases Conference in February. He also spoke at the conference with Vanessa Cashman of 12KBW on 'Current Issues in Cerebral Palsy Claims'.

William Audland KC and Isaac Hogarth secured a £20m settlement for a severely brain injured claimant in [EAC v Imperial College Healthcare NHS Trust](#).

Robert Oldham acted as junior counsel for the appellant in [PMC v A Local Health Board](#). The Court of Appeal clarified the High Court's inherent jurisdiction to make anonymity orders protecting vulnerable claimants. The judgment has far-reaching consequences for clinical negligence litigation and it affirms the importance of the proper administration of justice in cases involving vulnerable individuals, balancing this with the open justice principle.

Andrew Roy KC is acting in high value claims arising from widely reported failings in a midwife-led birth unit; *Charlton and Prudence v Gloucestershire Hospitals NHS Foundation Trust*. High Court proceedings are ongoing.

In *CWLX v Aneurin Bevan University Health Board*, Vanessa Cashman acted for an eight-year-old who developed hydrocephalus after birth which was not diagnosed when it should have been. The case settled for £24.5m on an 85% basis.

In *MB v SBL and Dr H*, Isaac Hogarth represented a woman left tetraplegic after a skydiving accident in a claim against both the skydiving company and her GP who certified her fit to jump despite her suffering from a psychological disorder which increased her risk of injury. The claim was compromised days before trial for a multi-million-pound sum.

Daniel Sokol secured a six-figure settlement for a Claimant who woke up during a hysterectomy but, owing to muscle paralysis, was unable to alert the clinicians to her awareness. She went on to develop PTSD.

Daniel also published a series of articles in the *Law Society Gazette* on [lawyers' bedside manner](#), [what to do when clients cry in conference](#), [professional composure in medicine and law](#), and [how to be trusted](#).

- *In the Matter of the Russian Aircraft Operator Policy Claims* (2025) Commercial Court, Simon Browne KC advised upon Security of Costs by way of indemnities, guarantees and application to Court in amounts exceeding £100 million.

Inquests & Inquiries

The inquests and inquiries team has been involved in two significant inquiries this year, the Lampard Inquiry into mental health treatment in Essex and the Infected Blood Inquiry.

The Lampard Inquiry began in 2024, and this year heard four weeks of evidence from bereaved families and friends of those who died receiving inpatient treatment.

The shocking testimonies covered failures to look after the physical health of older adults on mental health wards, use of surveillance technology to monitor patients in their bedrooms, inadequate attempts to resuscitate patients, lack of candour, poor communication with families and friends of patients, abuse of patients, and clinical negligence.

Dr Achas Burin, Annahita Moradi, Jake Loomes and Rebecca Henshaw-Keene are instructed on behalf of the largest cohort of participating families and patients. Steven Snowden KC stepped down from his role leading them in October 2025. Further evidence is expected to be heard in 2026.

Since the publication of the Infected Blood Inquiry's report in 2024, it received submissions to the effect that its recommendations were not progressing as hoped. The Inquiry resumed sitting for two days in May to examine the government's response, an unprecedented step for a public inquiry convened under the Inquiries Act.

An additional report was published and in November new regulations were laid before Parliament and a public consultation opened, inviting views on further changes to the compensation scheme.

An independent review of the body which administers the compensation scheme was also published and the Chancellor, Rachel Reeves, confirmed payments would not be subject to inheritance tax.

Steven Snowden KC led Dr Achas Burin acting on behalf of the largest cohort of the infected and affected.

Our members acted for bereaved families at a number of significant inquests this year.

Michael Rawlinson KC was instructed to represent the family of ex-Manchester United and Leeds United player, Gordon McQueen at the forthcoming inquest into his death. The inquest will consider the role of repeated head trauma acquired during his playing career in contributing to subsequent neurological deficits and his death.

Andrew Roy KC and Charley Turton acted pro bono for [the family of Eddie Cassin at his inquest](#). Eddie suffered from severe learning disabilities and died after an acute aspiration caused by breaches of his feeding plan contributed to pneumonia. The coroner made a prevention of future deaths report and a finding of neglect.

Thea Wilson acted for [the family of seven-month-old Tommy Kneebone at a six-day inquest](#) where the coroner found the child's death was contributed to by neglect. Tommy Kneebone died in January 2023 at Tunbridge Wells Hospital in Pembury. The coroner said that although Tommy had shown "clear red flags" of deterioration, hospital staff did not monitor or observe him properly, while repeated concerns by his parents were not acted on.

[Thomas Banks represented at inquest the family of Adrian Underwood](#), a security guard on the Oil Tanker MV Mercer Street who was killed when the ship was struck by an Iranian-manufactured weaponised drone during a terrorist attack in the Arabian Sea. The Coroner returned a conclusion of unlawful killing.

Ed Ramsay represented the family of Patricia Ann Tomlinson at the inquest into her death. She died of thiamine (vitamin B1) deficiency in December 2019 following a national stoppage - mandated by the MHRA - of bespoke parenteral nutrition bags. The Senior Coroner found the contingency arrangements put in place by the NHS were found wanting and possibly causative in Mrs Tomlinson's case.

Annahita Moradi acted as junior counsel for the Royal Military Police on the Independent Inquiry into Afghanistan.

Gareth McAloon [represented the family of Valerie Hill in a three-week, Article 2 inquest](#). The adequacy of falls risks assessments in residential care homes and the impact of lengthy ambulance delays in South Wales were examined, resulting in the coroner issuing two 'prevention of future death' notices to a local authority and Welsh ministers.

Cressida Mawdesley-Thomas represented the mother of Abby Johnstone-Nutting in an Article 2, jury inquest. Abby had been detained at St Mary's Hospital, London under the Mental Health Act when she escaped whilst being taken to vape by staff, dying by electrocution three hours later. A conclusion of misadventure contributed to by neglect was returned.
